Breeding Contract for Mare on Premises and/or Cooled Shipped Semen

This certifies _____ here referred to as mare owner has engaged one
Breeding service to _____ # _____ for the mare

Live foal guarantee.

The booking fee is \$100 payable with the signing of this contract. All other fees including the balance of the breeding fee will be paid before breeding or shipping semen. All other fees concerning your mare's board and breeding will be paid when picking up mare. Advance notice of 24 hours is required before picking up mare to give stallion owner time to prepare invoice for final settlement.

10% interest will be charged on all accounts in excess of thirty days.

A photo static copy of registration papers, both sides, a veterinarians' health certificate, including uterine culture, worming and immunization records will be furnished to breeder.

The Mare owner shall agree that each mare offered for breeding shall be in sound breeding condition and free from infection or disease.

The Breeder agrees to diligently try and settle the above named mare and shall have sole discretion of determining the best method of breeding such mare. If however, the mare does not settle, the Breeder shall be held harmless.

LIVE FOAL GUARANTEE: Live foal means the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal or if the foal is stillborn, a return season will be guaranteed the following year only, providing proper notification is given with a signed certificate by a licensed veterinarian within seven days of foal's death.

It is understood that the breeding farm, its owners, employees, veterinarians, and guests shall not be liable for any injury, escape, disability, or death of any horse on its premises. Also the above named Mare Owner will not be liable for any damage, injury or death to the breeding farm stallions, employees, or veterinarians.

The breeding season for this contract is Feb. 1st to July 1st of the year under contract.

It is further agreed that should the above named stallion die or become unfit for service; or if the above named mare dies, then the Mare Owner may substitute another mare or breed the above named mare to another stallion on the farm.

SHIPPED SEMEN: Shipment of cooled semen fees must be paid in full before semen is shipped next day air Fed Ex This fee is \$150.00. Mare owner agrees to return Equitainer by the fastest courier available after removing semen.

All paperwork sent with the semen must be filled out and returned along with the Equitainer or to the appropriate breed association.

Mistic Acres will make every effort to get cooled semen to any mare in good condition but will make no guarantees or warranties as to condition of semen upon arrival.

MARE CARE: \$10 PER DIEM FOR WET MARES AND \$8 PER DIEM FOR DRY.

When the above named mare owner signs and returns one copy of this contract to the Breeder it will then be a binding contract on both parties, subject to the above terms and conditions. This contract is not valid unless completed in full.
